Sub: MJPTBCWREIS – RLCs – Request to host the admission guidelines for admission into 5 YDC LL.B. Courses at MJPTBCWR Law Colleges in TSLAWCET 2025 portal –Reg.

With reference to the above subject and reference cited, I would like to bring to your notice that the Government of Telangana has permitted MPTBCWREI Society to introduce Law Courses B.A. LL.B. and BBA. LL.B. (5 Year Courses) in two Colleges at Hanumakonda and Rangareddy Districts, from the Academic Year 2023-24 onwards.

Further, the Society has established Mahatma Jyothiba Phule Telangana Backward Classes Welfare Residential Law College for Women, Hanumakonda, Hanumakonda District, and Mahatma Jyothiba Phule Telangana Backward Classes Welfare Residential Law College for Men, Kandukur, Rangareddy District, from 2023-24 onwards.

In view of the above, I request you to host the below mentioned Admission Guidelines of the Society for allotment of seats into five years B.A.LL.B course at MJPTBCWR Law College for Women, Hanumakonda District and B.B.A. LL.B & B.A. LL.B courses at MJPTBCWR Law College for Men, Kandukur, Ranga Reddy District, with an intake of 60 students in each course.

1. Students who passed Intermediate or equivalent examination in the academic year 2024-25, 2023-24 and 2022-23 are eligible to seek admission into MJPTBCWR Law Colleges.
2. The candidates should not cross the age of 20 years as on 01-01-2025.
3. BC/SC/ST/EBC students are eligible for admission.

Reservation of Seats:

- a) BC-A: 15%, BC-B: 25%, BC-C: 3%, BC-D: 17%, BC-E: 10%, MBC: 5%, SC-I: 1%, SC-II: 9%, SC-III 5%, ST: 5%, OC/EBC: 2%, orphan: 3%.
- b) If there are any unfilled seats in any category, they will be filled with BC

students. The carry forward principle in respect of BC students i.e., MBC to BC-A, BC-A to BC-B, BC-B to BC-C, BC-C to BC-D, BC-D to BC-E, BC-E to BC-A and so on will be adopted.

4. **Annual Income of the Parents/Guardian shall not exceed Rs.1,50,000/- in Rural areas and Rs.2,00,000/- in Urban Areas.**
5. **This is 100% Residential Program. No Day Scholars shall be allowed.**
6. **No Mobile phone is allowed in the Campus.**
7. **The candidate should not be married as such admissions are not feasible in the residential pattern of the college.**
8. Other admission guidelines as followed by TS LAWCET shall be applicable to MJPRLCs also.
9. The candidates who got allotment into RLCs shall have to pay the following fee at the time of reporting to the College.
Maintenance Charges: Rs. 4000/- (Non-refundable)
Caution Deposit: Rs.4000/- (Refundable after the completion of Course).
10. The candidates who are admitted into RLCs have to abide by the rules and regulations of MJPTBCWREI Society.
